# LEMONT PARK DISTRICT

## Purpose

---

The Lemont Park District was organized and established as a separate unit of local government in 1966 by a referendum.

The mission of the Lemont Park District is to enhance the quality of individual experiences by providing safe, accessible and premium facilities, parks and programs to the community while being fiscally and environmentally responsible.

## Population

The Lemont Park Districts population per the 2010 census is 22,325\*.

*\*This figure has been derived from projected populations based off of Census reports along with other database information as it relates to the area in which the District serves.*

## Assessed Valuation

The estimated equalized assessed valuation for real estate for 2020 is \$1,049,968,750.

## Tax Rate

The estimated property tax rate for 2020 is .49 per \$1,000 of assessed value.

## Current Budget

The operating budget for the fiscal year 2021 is \$5,164,977 (less Debt and Capital.) The fiscal year begins January 1 and ends December 31.

## Staff

The Park District has an appointed Executive Director responsible for the administration of the Park District. The District employs 21 full time staff, 7 part-time regular staff and between 100-300 part-time, seasonal and temporary workers.

## Board of Commissioners and Administrative Staff

---

The Lemont Park district is governed by five elected residents of Lemont who voluntarily give their services to the community. The Commissioners elect a President and Vice President and appoint a Treasurer and Board Secretary. The Park Board holds its regular meetings on the fourth Wednesday of each month at 6:30 p.m. at the Safety Village, 55 Stephen Street, Lemont. Date & time subject to change. Due to pandemic, Board Meeting locations are subject to change from meeting to meeting. Please see individual agendas for specific meeting location and information. Residents are invited to attend and are welcome to make suggestions or comments to improve the programs or facilities offered.

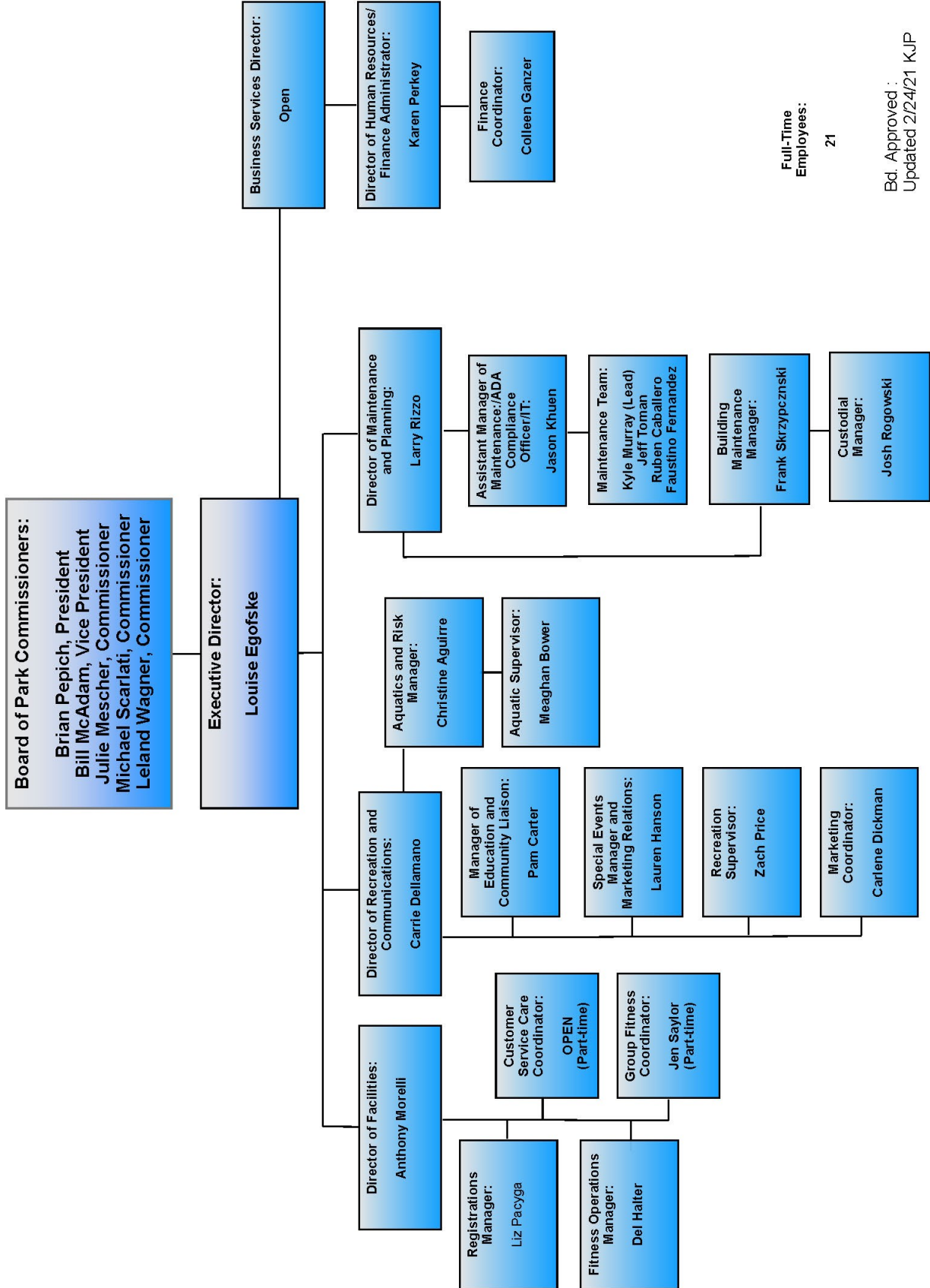
