

OPERATING BUDGET

In a typical fiscal year, the operating budget is approximately \$9 million dollars of which approximately 56% is funded by property tax revenue. The remaining 44% is generated from program user fees, grants, fundraising and rentals. In 2022, as operational restrictions related to the recent pandemic gradually lifted, programs are once again offered, members are returning to The CORE and residents are enjoying our facilities. In addition:

- Revenue has increased 9% due mainly to the expansion of programs offered and the resulting increase in resident participation.
- Capital expenditures significantly increased to \$3.6 million dollars, including \$1.6 million dollars invested in land acquisitions for future park development.
- Registration fees contributed approximately 27% of total District revenue for 2022, up from 23% in 2021 reflective of our increased programming. More programs resulted in increased resident participation. Total enrollments in 2022 were 10,545 vs. 9,720 in 2021.
- Building and pool rentals have increased by 41%.
- Staffing changes include the addition of two (2) full-time replacement maintenance/custodial employees.
- Cost containment continued and deferral of projects also supported favorable results.





THE LEMONT PARK DISTRICT & THE LEMONT JUNIOR WOMAN'S CLUB WIN BEST PARTNERSHIP AWARD



This Illinois Association of Park District's (IAPD) award recognizes non-governmental organizations that have collaborated with a park district enabling the public agency to initiate a major improvement that enhanced residents' quality of life and would not have been achievable without this partnership.

Lemont Park District's partnership with Lemont Junior Woman's Club has enhanced our parks and enriched the lives of residents. For nearly two decades, the Lemont Junior Woman's Club has beautified our parks with memorial tree and bench contributions, but their generosity doesn't stop there. In 2005, Centennial Park's playground was renamed the Lemont Junior Woman's Club Playground following the organization's gracious funding of new equipment.

Twelve years later, they raised \$30,000 for renovations over a three-year period to help fund a new LJWC Playground! The playground is ADA accessible and offers an exciting, creative space for children of all ages and abilities.

Distinguished Park and Recreation

Accredited Agency

The Lemont Park District has been recognized again as an Illinois Distinguished Accredited Agency by the Illinois Association of Park Districts (IAPD) and the Illinois Park and Recreation Association (IPRA).

The Illinois Distinguished Accreditation program provides an opportunity for agencies to undergo a comprehensive evaluation focusing on transparency, fiscal responsibility, operational best practices, environmental initiatives and safety. This process showcases agencies that have met state guidelines to provide exceptional park and recreation services to their community. In 2015, the Lemont Park District was initially accredited. Typically, an accreditation expires after six years. However, due to a delay in evaluations in 2020 because of the pandemic, the Lemont Park District received re-accreditation in 2022.

The end result is to improve the quality of life for Illinois residents. This program gives recognition to park and recreation agencies that go above and beyond in dedicating themselves to offering quality programs and services designed to fulfill their community's needs.

KETTERING PARK

In the Fall of 2021, a well-attended Make Your Park resident planning meeting took place regarding the new Kettering Park Development project. Groundbreaking for this exciting new addition to the Kettering subdivision took place in the Spring and the park opened in August of 2022. Kettering Park features a variety of ADA accessible play pieces for various ages, a synthetic turf surface, a solar charging station, seating area, and parking.

THE CORE TRAIN STATION OUTDOOR FITNESS COURT

In 2020, the Lemont Park District was awarded a National Fitness Campaign (NFC) \$30,000 Healthy Cities Grant. Fitness Court branded outdoor gyms boast a variety of key elements which enable individuals to reach their fitness goals. Known as "the world's best outdoor gym," Lemont's new, world-class NFC Fitness Court was planned to be located in Downtown Lemont. Due to circumstances related to the pandemic, as well as land allocation details, the project was postponed. The District was very excited to move forward with the installation plans in 2022. The Village of Lemont was an amazing partner in this endeavor assisting with construction and installation costs. The location and public common area was provided by the Illinois Department of Transportation (IDOT) and in partnership with the Village. The Lemont Park Foundation also supported this project with a \$10,000 donation that was used for customization and landscaping. The Lemont-Homer Rotary Club generously donated new benches. The CORE Train Station is located on Front Street and is open for use!

Make Your Park

Lemont Park District WINS OSLAD Grant!

In 2021, the Lemont Park District applied for a Open Space Land Acquisition and Development (OSLAD) grant to assist in offsetting the costs associated with developing the new Athens Park Downtown Lemont project. And on July 8, 2022, it was announced that the Lemont Park District was selected as a \$400,000 grant recipient! This grant will greatly assist with the revitalization of this area.







ATHENS PARK STATUS

Complete with recreational and natural amenities as well as trail linkages, Athens Park will enhance the quality of life for so many. The Lemont Park District and Village of Lemont are in partnership with the Metropolitan Water Reclamation District (MWRD) for the use of this land and developing this parcel involves many moving parts such as various permitting measures. Beginning in the spring of 2023, this area will undergo the first phase of ground-breaking development. This will include clearing and remediating the area in preparation for the park buildout which is slated to take place in 2024. The Lemont Park District is committed to communicating project updates as they become available.

The Future is BRIGHT!

NEW LEMONT NEIGHBORHOODS & PARKS COMING SOON!

As the Lemont community continues to grow, so does the Park District family. This year, two new subdivisions are slated to be developed in Lemont, Copper Ridge and Gleneagles. Both neighborhoods will include single family homes as well as townhomes. The Park District was given both a land donation and park allowance to develop a park in each area. Copper Ridge will include two synthetic turf bocce ball courts as well as a synthetic turf putting green. Gleneagles Park will be home to a fun, state-of-the-art play structure, path, full basketball court, synthetic putting green, two pickleball courts and a pavilion! The park will also pay homage to the beloved Gleneagles Golf Course in some design elements. Construction on both parks are scheduled for groundbreaking in 2023.



MIRACLE FIELD RENOVATION

The Lemont Park District is pleased to announce that the agency was selected as a grant recipient for the 2023 Open Space Land Acquisition and Development (OSLAD) award program on March 1, 2023. The \$600,000 grant award, in which the District applied for at the end of last summer, is designated to assist in funding the redevelopment of the existing Miracle Field located at the Park District's Centennial Campus.

The Park District's Miracle Field was originally developed in 2007 and is slated to be renovated in 2023. Not only has this multi-use field has been a great asset to SEASPAR Special Recreation participants and Lemont Baseball and Softball Club, but it has also been the home to outdoor fitness classes. athletic programming, day camp activities and much more. However, the field does have its limitations as it is not a regulation size for league game play. Additionally, the rubber surface has reached its end of life. Refurbishing the Miracle Field into a modern ball field with upgraded amenities and accessible turf surface, will be incredibly beneficial to all users for many years to come.

In addition to the OSLAD Grant award, the Rizzo Family and the Danny Rizzo Foundation have made a generous \$25,000 contribution towards this project. Combined, these funds will greatly help offset the costs associated with Miracle Field Renovation Project which will include not only extending the field to a 200-feet regulation sized field, but it will now be astroturf. In addition, ADA accessible dugout areas with shade, a new netting system, a batting cage and improved spectator areas are also part of the renovation which is scheduled to begin mid-summer.
